**4. FIRST AID MEASURES**

## 5. FIRE FIGHTING MEASURES

### **Suitable extinguishing media**

Methods for containment	Prevent further leakage or spillage, if safe to do so.

Methods for clean-up Use dust mask and/or reasonable personal protective equipment as required to avoid breathing dusts.
