### 4. FIRST AID MEASURES

- Eye Contact      Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.
- Skin Contact      Wash with soap and water. If injury occurs, or if discomfort or irritation persists contact a physician.
- Inhalation        If inhaled and discomfort occurs, move to fresh air, and keep person at rest in a position comfortable for breathing. ## 5. FIRE FIGHTING MEASURES
