### 4. FIRST AID MEASURES

**Eye Contact** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

## 5. FIRE FIGHTING MEASURES

### **Suitable extinguishing media**
