**4. FIRST AID MEASURES**

Eye Contact

5. FIRE FIGHTING MEASURES

**Suitable extinguishing media**

Use extinguishing media suitable to local circumstances and the surrounding environment. Options in this case include water, CO<sub>2</sub>, ABC Dry Chemical extinguisher, or foam. Avoid stirring up dust extinguisher stream.

**Specific hazards arising from the chemical**

Thermal decomposition can lead to release of irritating and toxic gases and vapors. In the event of fire, do not breathe fumes.

Methods for containment	Prevent further leakage or spillage, if safe to do so.

Methods for clean-up

Use dust mask and/or reasonable personal protective equipment as required to avoid breathing dusts. Moisten or cover powder spill with plastic sheet or tarp to minimize spreading. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Soak up excess with inert absorbent material. Clean contaminated surface thoroughly.
