4. FIRST AID MEASURES

Eye Contact	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions	Use dust mask and gloves as needed or other reasonable personal protective equipment as required to prevent contact with eyes or skin. Remove ignition sources prior to clean-up.
