4. FIRST AID MEASURES

Eye Contact

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

Methods for clean-up

Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Soak up excess with inert absorbent material. Clean contaminated surface thoroughly.
