4. FIRST AID MEASURES

Eye Contact

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

Specific hazards arising from the chemical

Methods for containment	Prevent further leakage or spillage, if safe to do so.

Methods for clean-up

Use dust mask and/or reasonable personal protective equipment as required to avoid breathing dusts. Moisten or cover powder spill with plastic sheet or tarp to minimize spreading. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Soak up excess with inert absorbent material. Clean contaminated surface thoroughly.
